SUBJECT: Continuation of Current RC MOS Conversion Bonus Implementation Policy

2. Effective immediately the current RC MOS Conversion Bonus implementation policy is extended IAW above references until superseded or integrated in Army regulation. This memorandum allows the Army National Guard and the United States Army Reserve to enter into MOS Conversion Bonus agreements after December 31, 2006, subject to the requisite congressional reauthorizations of section 326 of title 37, United States Code.
